DESIST AND REFRAIN ORDER

(For violations of section 31110 of the California Corporations Code)

The California Corporations Commissioner (“Commissioner”) finds that:

1. Mailbox It Group, Inc., formerly known as Mailbox It Stores of America, Inc. (hereafter referred to as “Mailbox It Group”), is a Missouri corporation operating under the trade names Mailbox It and Mailbox It Express. Mailbox It Group sells nationally franchised stores offering parcel delivery, packaging, mailbox rental, and related business services. The president of the Missouri corporation is Greg J. Roberts (“Roberts”). The Mailbox It trade name has been in use since at least 1998, and the corporate headquarters is located at 1031 E. Battlefield Rd., Suite 217A, Springfield, Missouri, 65807.
2. Beginning in March 2006 or earlier, Roberts offered or sold Mailbox It franchises to California residents.
3. During August 2008, Mailbox It Group offered franchise opportunities on its website www.mailbox-it.com. The website advertised there were California Mailbox It stores located in Long Beach, Orange, Victorville, and Yorba Linda.

1 4. Neither Mailbox It Group nor Roberts has registered to offer or sell franchises under the
2 California Franchise Investment Law.

3 5. Further, on August 6, 2008, the Commissioner ordered Roberts and his business partner,
4 Keith Lawson, operating under the name Salad Kings, Inc., to desist and refrain from offering and/or
5 selling unregistered TossAcross franchises in California in violation of Corporations Code section
6 31110.

7 Based upon the foregoing findings, the California Corporations Commissioner is of the
8 opinion that Mailbox It Group, Inc., Mailbox It, Mailbox It Express, and Greg J. Roberts have offered
9 and/or sold franchises in California. The California Corporations Commissioner is of the further
10 opinion that Mailbox It Group, Inc., Mailbox It, Mailbox It Express, and Greg J. Roberts have offered
11 and/or sold franchises in California that were subject to registration under the Franchise Investment
12 Law without the offers and/or sales first being registered, in violation of Corporations Code section
13 31110. Pursuant to section 31402 of the Corporations Code, Mailbox It Group, Inc., Mailbox It,
14 Mailbox It Express, and Greg J. Roberts are hereby ordered to desist and refrain from the further
15 offer or sale of franchises in this state unless and until the offers have been duly registered under the
16 Franchise Investment Law or are found to be exempt.

17 This Order is necessary, in the public interest, for the protection of investors and consistent
18 with the purposes, policies and provisions of the California Franchise Investment Law.
